


Brief Preamble of Organization...








We encouraged these registered cooperatives society members to understand the formalities of avail credits from main stream financial institutions such as nationalized bank in their operational areas. A competent resource person was hired to conduct the sessions. During the training program we also touched upon topic likes various government schemes, market functional strategies etc. Altogether more than 800 cooperatives members took part in the training program.One of the planned results was to initiate small scale business by the registered cooperative societies. All 4 of them have initiated the same. The cooperative at of

Vadgam has opened shops at Vadgam and Palanpur city where they are selling cloths as well as handicraft articles. Cooperative members at Meghraj are involved in selling handicraft item like doormats vegetables, washing powders, and at Nanakatharia, cooperative members are also involved in selling ladies garments and washing powders. And at Asal, cooperative members are involved in selling garments like saaries, they purchase plain saaries and make them beautiful by patch work.

We were also able to access financial assistance from Rural Technology Institute- Government of Gujarat for skill development training program for the cooperative members. Altogether 150 cooperative members from four partner locations received training program on livelihood skill

training program, the participants received Rs. 2,25,000/- as stipend and received Machines worth Rs. 1,75000/- for Paper plate and cup making. we have also impart other livelihood skills training to approximately 907 cooperative members on different livelihood skill such as tailoring, beauty parlor, handicraft and kitchen gardening. As a result of the training program many of the participants have started their own business such as tailoring 38 women, kitchen garden 180 women, beauty parlor 20 women, handicraft 56 women and 10 of them are involved in cookery.

Achievements of "SAFE MOTHERHOOD HEALTHY CHILDHOOD"

The intervention of SSSS in Safe Motherhood Healthy Childhood project has made us realize remarkable progressive growth of change in the mindset of the poeple who are under our care and the results achieved. However, these results could be interpreted in terms of the status of implementation of the planned activities; the quality of progression, process and mechanisms adopted; VHWs commending enthusiasm; staff capacity and measures adopted in the project for ensuring RCH indicators & access to the government services on health and the active participation of these communities in the project. The achievements gained are far more heartening than initial stages of the project.

We are happy to articulate that through this project, we could interact with different groups of people though some of which are of cyclical in nature such as pregnant mothers, lactating mothers, mother-inlaws, youth and village Health Committee in every village of the project area. Our working presence has educated them on various kinds of health issues that invoke their realization of participation for progression of their very own self and village development.





- 15 Village Health Workers of Patan and Mehsana are fully trained
- VHCs have worked as pressure groups in the villages & have resolved health issues and village issues like cleanliness, mid day meal, drainage system in the village, RCC roads, chlorination of drinking water tank etc.
- ◆ 56 people availed Rs. 5000 from Govt. Health Schemes.
- 2513 patients of 42 villages are treated in the STI/RTI camps, immunization camps, gynec camps & pediatric camps
- ◆ 130 VHC members, 90 village people & 15 VHWs visited PHC, CHC & Civil Hospital.
- Antenatal check up has become 100/% in 2014 compared to 91% in 2012.
- Home deliveries of children have completely stopped and the deliveries are done either in PHC or in other private available health units.
- ✦ IFA tablets by pregnant women was only 88.2% in 2012 and it has become 100% in 2014.
- IMR is reduced by 50% from the existing rate in 13 villages of Patan and Mehsana.
- As a result of awareness created among women (mothers) on the importance of immunization, rate of immunization has increased from 81.05% in 2012 to 92.07% in 2014.
- Mothers have changed their pattern of behavior in giving supplementary food for the children after six months. It was 78.05% and it has gone up to 92.07% in 2014.



Joy of New Life

On 9th January 2015, Pediatric Camp was conducted at Mandali centre in Mehsana District. Pathan Salehabanu Jakhirkhan, 14 years old, staying at Pathanvas, Mandali had come for medicine. One of our Village Health Worker happened to witness a boil, some kind of a knot on her neck. She immediately presented her case to the Dr. Jay Patel who had accepted to be present for this campAfter examining the concerned boil on the girl's neck, doctor asked the girl's mother if there had been any case of Tuberculoses in their family. The mother responded in negative. The doctor in a soft manner suggested her mother to show her daughter at the Civil Hospital, Mehsana.

On 19th January 2015, mother came to VHW with an address of a private laboratory named Ravi Pathology Diagnostic Centre, Mehsana asking her to accompany them. Concerned about the girls health, VHW went with them to the said hospital. When she had a blood test, the report was found to be positive. The girl was indeed suffering from Tuberculoses. As soon as her case was diagnosed, VHW made a headway to the Lions General Hospital, Mehsana for further treatment else they would end up in spending more money.

Next day, on 20th January 2015, Dr. Sandeep S. Chaudhary put Salehabanu on medications for 10 days. As a follow up case, again on 31st January 2015, VHW went with them to the same doctor for further medicinal course. Salehabanu was examined to be in category 1 of TB treatment. It was a matter of small gesture from VHW to shift the case from the private hospital to the government hospital and avail the facility of free medication.

Living for Others

This story belongs to a village named Masali of Radhanpur Taluka of Patan District. There are eight

falliyas/areas in this village. There is a prominent lake in this village where people use it for their daily purpose. They use it from washing their clothes to clean their animals. Gradually they reduced the usage of cleaning clothes but the animals would still drink water from it. Water used at their household didn't have a proper drainage system. Hence this water logging was directed through a pipe system into the lake. Eventually people started dumping other things as well into this drainage that made the lake accumulate more dirt than before. One way the issue



of dirty water was resolved but it aggravated another hazard. This lake happened to be very close to the Thakors' faliyu/area. The smell of the dirty water was so powerful that this community felt humiliated as they couldn't even stay in their own homes.

Under the able guidance of Sabarmati Samruddhi Seva Sangh Gandhinagar, during the Safe Motherhood Healthy Childhood project, it had formed a Village Health Committee consisting of 12 members. Regularly, once in a month they would come together to discuss their village related problems and would understand ways & means to get the issues resolved. On 22nd July 2014, this VHC members got together to discuss the problem of this lake being polluted, and they came to a conclusion that they will write an application to the Sarpanch (head of the village) to end this menace. They gave an application to the Sarpanch in the following month and soon the action was taken in directing this sewage waters to its proper location and stopping the sewage water from polluting this lake.

Though the work is completed through the support of the VHC, water of the lake is still need to be purified. Therefore VHC decided to let the lake dry at first instant and then as the new monsoon begins to get it filled with clean waters. Meanwhile they would put medicine into the lake to make it mosquito free. As they begin their course of action, Takor community could breathe fresh air and could stay in their own homes. Surroundings are cleaned and they are alert not to allow any dirt to flow in from any corners. With the help from VHC people themselves monitor the surroundings of the lake.

Success Stories

Green vegetables from green house

Two of the cooperative members – Mani Ben and Leela Ben at Meghraj managed to gather courage to have their own green- house worth Rs. 30,0000/each. Both of them went to the KrishiVigyan Kendra and requested officials for technical

assistance and financial assistance. however, the officials said yes for setting up the green house but not the financial part. After Maniben inspecting vegetables in her green- house receiving answers from KVK thev



were had mixed feeling, but then they decided to go for it. They took loans from cooperative society and purchased the green house and KVK helped them to set up. Leelaben in her green house Both these project participants started seasonal vegetable cultivation from the year one. During the year they have three crops, each season they earn Rs. 10,000/- to 8,000/- profit. Vegetables cultivated are sold in the villages and in the market. Within two years they repaid their loan and season by season they increase the variety of vegetables in their green house and intend to expand the green house in the near future, they said.

Indigenous technology to beat the heat

s the temperature sores up to 45 to 48 degree Celsius during summer season in Gujarat. Most of rural populations do not have the luxury of having cold water from refrigerator. This year the cooperative members of Meghraj brought out an innovative idea to make water cool during the summer season. The 7 members of the cooperatives prepared low cost (Rs. 50/- per unit) a pot -holder, which can be hanged on the open area of the house or in trees nearby. The members hanged the pot holder, with water filled in the mud pot and served whoever past through or came as guest every day. This continued for a week. One week was enough for the advertisement. The demand started pouting in the second week. They sold 7 hundred units during the summer season.


