

## Preamble of the Organization

Sabarmati Samruddhi Seva Sangh, Gandhinagar(SSSS) is a Charitable, Voluntary, Non Government Organization working in six districts of North Gujarat namely Aravali, Banaskantha, Gandhinagar, Mehsana, Patan and Sabarkanatha. The Society & the Trust was registered with the Charity Commissioner on 19th July 2003, bearing Society reg. no Guj/1077/Gandhinagar & Trust reg. no. F/1033/Gandhinagar. The main aim of the Society is upliftment of the poor and the marginalized from the rural areas of North Gujarat. At present the society is actively involved in empowerment of poor and marginalized especially women and children through various programs like empowerment through Women's Co-operatives, Trainings on Health and Hygiene, Reduction of IMR, MMR, Improvement in RCH status, Help line for Children - Childline 1098, etc. The office bearers of the Society are committed social workers who have devoted their lives for the service of humanity. Society also actively involved in promoting income generation programs through Women's Co-operatives.



## Mother & Child Safety

The Mother & Child Safety project funded by Bishop's Conference of Italy has been functional in 18 villages of two districts of Aravali & Sabarkantha through our four operating partners (Himmatnagar, Khiloda, Nanakantharia & Meghraj). Keeping in view the high occurrences of women being largely anaemic, having major issues reproduction and child health due to ignorance and superstition, partners have identified 20 VHWs as a local human resource to enhance their



knowledge and skills and to ensure that women receive services and care from the public health system during pregnancy, childbirth and postnatal phases. Trained VHWs facilitate timely referrals along with Village Health Communities (VHC) in linking with the Government local body called panchayat and local health units to receive their health services appropriately.

- > 18 VHCs are formed and 216 People directly participated in mother & child safety project
- 216 awareness to local communities on health topics conducted and 6601 of people attended and gained knowledge on health
- 72 RCH awareness to specific groups conducted. 1273 of people attended and gained knowledge on health
- > 18 General Health Camps conducted wherein 1373 patients treated at the camp
- ≥ 18 Immunization Camps conducted and 448 beneficiaries treated in the camp
- > 18 Gynec Health Camps conducted where 650 women got treated in the camp
- 20 personnel are trained as village health workers and are confident leaders in health issues
- 20 VHWs having received guided orientation were able to conduct one hour health education session to the communities every month
- 4 operating partners and 20 VHWs have attended training like record keeping & documentation which helped to maintain proper records of the project
- Having learnt methods of health teachings, 20 VHWs support Immunization Day held every month in their areas
- Health awareness conducted on regular basis have benefitted 316 people to have availed Rs 1, 77,600/- from various government schemes
- At least 784 people avail direct benefits from Primary Health Centers (PHC), Community Health Centers (CHC), civil hospitals promoted through 18 exposure visits initiated at grass root level

## Nutrition Improvement through Community Empowerment (NICE)

Sabarmati Samruddhi Seva Sangh (SSSS), Gandhinagar is actively involved in developmental activities like health, education, watershed, community drought management, and natural resource management, formation of Self Help Groups, Childline 1098 and empowerment of women through Co-operatives. As part of our health activities, a project to address malnutrition issues of communities of backward areas of



Aravali district has just started. SSSS envisage identifying malnourished children from 0 to 6 yrs along with their mothers & improving their nutritional status by accessing Government health services. We hope that these communities become aware of health issues specially the women and manage their health problems on their own. The project will be implemented in 39 villages of Aravali district through four operating partners. There will be four groups namely anaemic child & women, young adolescent girls, mothers of 0 -6 years children and Village Health Community (VHC). 13 village health workers (VHWs) will be selected and trained on nutritional health. They will empower the communities to improve malnutrition data in their respective areas. They will ensure ways & means to get health entitlements from the government to the communities. Each village will also have a VHC who will facilitate and link with the Government Local Body called Panchayat and local health units in matters of health related activities so that communities receive their health services appropriately. We believe to achieve:

- 40% increased from the present ratio in the consumption of nutritious food among women and children in 39 villages of Aravali by the end of three years.
- 2. 45% of newly born babies are born healthy (>2500 gms) in the 39 villages of Aravali by end of three years.
- 3. 80% Male and Female in 39 villages are sensitized on importance of nutrition by the end of 3 years.
- 4. Thirteen Village Health Workers are fully trained on health issues.

Various health awareness trainings are planned for the communities; various topics on health will be dealt with in the training of VHWs; training on leadership and counseling will be given to the VHWs; several health camps are planned for the communities with the help of the Govt. Health Units; couple of exposure visits are also planned for the VHWs and VHCs, celebration of World Health day, Anaemia day, Nutrition day and some competitions such as healthy baby and healthy diet. The project is for a period of three years. The VHC members will take an important role in the sustainability of the project after the project comes to an end. They will continue to play their role in linking with the Panchayat and the Govt. Health Units for various Gov ernment health activities and the schemes by which the communities can benefit.

## SANGATH

Sabarmati Samruddhi Seva Sangh gives top most priority in building capacity of the target communities. It seeks to build up the inner potentials and capacities of the individuals, families, affinity groups and communities within the operational villages and equip the vulnerable and marginalized groups to fight against the deprivation, marginalization and exploitation they experience in their day-to-day life. In this capacity building process, SSSS plays the role of an external facilitator and a constant companionship in the journey of the poor towards their empowerment and self-development. SSSS does not offer solutions to the different issues and problems of the poor it works with instead it motivates to



enable the poor to build up a strong foundation and a platform to identify their own development need in finding solutions for their own problems and issues.

"SANGATH" project works closely with Core Committee in project implementation. Subsequently, the role of SSSS limits in advisory capacity to these Cooperatives. The operating partners too are required to gradually withdraw and offer handholding support as and when demanded. The four cooperatives that have been legally registered as a separate entity continues to have placed increased emphasis on the process based approach of empowerment of Cooperative. Its members are growing and learning to take leadership eventually and subsequently become a resource for socio -economic development.

- Registered cooperative societies at Meghraj, Nanakantharia, Khiloda and Vadgam are involved in small scale business
- New cooperative formation in process at Radhanpur, started with 161 membership & Rs.1,02,800/-
- Cooperative society at Nanakantharia is involved making washing powder and selling it at a nominal price
- Cooperative society at Meghraj is involved in vegetable cultivation through greenhouse and selling the same and also supplying seeds and fertilizers to farmers
- Cooperative society at Vadgam is involved in small business like handicraft articles, selling cloths, making paper articles, plastic rope articles and also involved in selling cloths by setting up two shops in Palanpur city
- Cooperative society at Khiloda is involved in small business like selling saris and garments
- 20 members of the cooperative societies are involved in beauty parlor
- 178 cooperative members are involved in handicraft activities
- Cooperative members facilitated to avail various schemes like Kunwar bai nu mameru and old age pension to 152 individuals. Cooperative members received benefits from various Govt. schemes like Manav Garima Yojana (120), MNREGA Yojana (700), Manav Kalayan Yojana (123), Indira Avas Yojana (65), Sardar Avas Yojana (87), Toilet Scheme (300) and Krushi Rath Yojana(23)

# SSSS Gandhinagar Childline 1098

**SSSS GANDHINAGAR CHILDLINE** is a national 24x7, free, phone emergency outreach service for children in need of care and protection, linking them to long term rehabilitation. Any child or concerned adult can call 1098 to access the childline service any time of the day or night.

CHILDLINE team works round the clock, visits new location, confers with various stakeholders from district administration and tries to execute each case. Children helpline has been awarded to us by Ministry of Women & Child Development, Delhi through Childline India Foundation, Mumbai to work in Gandhinagar district since August 2015.

### @ Medical Help: 49

Children are rescued through child help line and in cases where immediate medical attention is required are taken to civil hospital. During the year 2016-17, with the cooperation from the doctors through the superintendent, childline team has been able to provide medical treatment to 49 children. 16 cases of children with high fever, 14 children severely under nourished, 13 children of skin disease, 7 children infected with chicken pox. Our interventions give relief to parents and they are always ready to support us in disseminating the awareness free of cost service rendered by SSSS Childline.

### @ Protection from Abuse: 140 cases

Childline is continually giving protection to children not only as and when required but also at a critical time & situation.

**Child labour:** SSSS admits to have rescued 33 children from child labour and have rehabilitated them to a better life style in our society. Directly involving ourselves in TASK FORCE with "Labour Department", "Police Department" and "Child Protection Unit" has rejuvenated our spirit of working together with the government for the cause of children.

**Child begging:** SSSS Childline intervened to rescue 37 children from begging and counselled the parents and guardians to keep children away from such activities and supported them to re-admit their children to school.

**Child marriage:** Our childline team succeeded in intervening atleast 5 child marriages happening on the spot. We could reach the location with just a call away by someone in the public. In coordination with superintendent of police (S.P) Gandhinagar, our team could protect the girl child in all cases falling in the trap of social evil. Later on follow up of these cases through counseling helped in solving the problem.

### @ Missing Children: 18


Childline receives various kinds of calls especially in the wee hours of the night. 15 calls of missing children were received during this year. Our team is so delighted to have identified and rescued these children and are given into safe hands of the parents after due process. Childline from other states reported 3 missing cases to us which were tracked successfully by SSSS Childline and were presented to their parents with the help of the police protection.

### @ Education Sponsorship: 65

The mandate of RTE Act has supported Childline to admit children from marginalized and poor communities.

46 children got admission into private and Government schools. 12 children were helped to obtain Adhar card.

7 children received scholarship from palak mata-pita yojna. Education Department has been caring to help the children in need.



## In Additional...

### **Task Force Drive**

SSSS was successful in organizing special task force drives with the Gujarat government officials from Labour Office, factory Inspectors, Police officers, Child Protection Officers, Social Defense Officers. During the year 2016-17, Childline team could solve 19 cases namely cases of child labour (8), child begging (5), child marriages (6), Children protected from abuses are from Mansa, Dehgam and Kalol talukas. Direct intervention at the spot and rescuing children from the menace speaks volumes of the childline team of SSSS Gandhinagar.



### **Girl Child Day**

On 9<sup>th</sup> September 2016, Girl Child Day was celebrated at Jeevan Vikas Kendra, Pethapur. 285 girls from 21 Associate Partners of SSSS voiced out slogans in the rally "Beti Bachao - Beti Padhao, Bal lagn atkavo, Beti - ghar ki laxmi hai, Bal Majuri haai haai" to endorse the theme "Girl: In the footsteps of Mother Teresa". The presence of Archbishop Thomas Macwan, Mrs.

Sharmila from UNCIEF, Mrs. Minaxiben (Police Inspector of Women's Desk) and Missionaries of Charity Sisters, Ahmadabad, not only enhanced the joy of the children but also gave impetus to work for the girl child rights & protection, justice and development.

### We Revitalize Placement...

SSSS is instrumental in providing free placement to College students. The entire month of January 2017, has been a boon to 10 students from Shree Sarvajanik MSW College, Mehsana to learn about the functioning of an NGO and how do they differ in upbringing of a society. Students had opportunities to conduct a survey, analyzing its data to derive at a proper conclusion.



Writing a project proposal with its problem tree and analysis, facing an interview and creative way of functioning at field work, etc are some of the benefits of the month. In the presence of the Director of SSSS and Prof. Monika of Shree Sarvajanik College awarded the students with a certificate and encouraged them for a bright future ahead.


